### **MISSION STATEMENT**

To provide structure, accountability, and encouragement to men who are participating in a 12 Step recovery program, in order to help them establish a positive support system as well as a lifestyle of sobriety.

### **Qualifications for Admission / Participation in the Program**

- Strong commitment to stay sober & enough stability to remain sober long term
- Clean of alcohol and all drugs, including marijuana, narcotic pain killers, and any prescription or over-the-counter medications or substances that are addictive or can be abused recreationally upon intake and at all times while participating in the program
- Motivation to work a 12 step Program to include weekly meeting attendance, step-work, and working with a sponsor
- Willingness to fulfill program expectations, including but not limited to: house chores, curfew, and drug and alcohol testing
- Ability to obtain and maintain full time employment
- Ability to pay the monthly program fees – amount varies by phase, about \$650 per month
- Willingness to make a minimum of 90 Day Commitment to the Program

### **Disqualifications for Admission**

- Lighthouse is not a medical or detox facility, and therefore does not accept applicants who are currently under the influence of alcohol or drugs. If an applicant has recently used alcohol or drugs, he must either go to detox prior to entering the Lighthouse program or be able to pass a drug test.
- Lighthouse is currently not accepting Sex Offenders
- Lighthouse is currently not accepting parolees of any county other than Larimer. If you are on parole, you must be a Larimer County Parolee prior to applying for admission. If your intention is to transfer to Larimer County Parole, the transfer must be complete prior to applying for admission to Lighthouse.
- Lighthouse is not accepting applications for men who are unwilling or unable to make a 3-month commitment to the program.

### **Included in the Monthly Program Fees are the following:**

1. A shared bedroom (2 men per room)
2. Food – in the form of an open kitchen, stocked with food, that you can use to prepare meals as desired
3. Basic Utilities
4. Use of laundry room
5. Wi-Fi
6. Standard UA Drug Tests
7. Breathalyzer Testing

### **Not included in the Monthly Program Fees:**

1. Cable TV in bedrooms. Cable TV is provided in family room and dining room.
2. Specialty Drug Testing Fees – such as kratom, dextromethorphan, hallucinogens, etc., not included in standard UA.

**Admission Process** - Admission into the program at the Lighthouse is not guaranteed. After an application and interview are completed, staff at the Lighthouse will contact references and review the information received during the screening process to determine whether or not the applicant is a match for the program offered at the Lighthouse. The admission process can take anywhere from a few business days to a few weeks, depending on the specifics of each applicant's situation. If accepted into the program at the Lighthouse, the applicant will be brought into the program as space allows.

**Fees** - Fees for the first 30 days (\$650) plus a \$50 administrative fee, for a total of \$700 are due on the day you move in. Unfortunately, there are no grants or scholarships available at the current time, and applicants cannot enter the program without advance payment. Because we are a sober living facility and not a medical facility, Medicaid, Medicare, and private health insurance are not accepted.

**Identification** - 2 Forms of ID are required at the time of intake: Valid Driver's License or State Issued Photo ID, and either social security card or birth certificate.
